WHEREAS, in order to identify qualified and responsive providers for these services a Request for Proposals (RFP) process for administration services has been completed in accordance with State and Federal requirements for the CDBG and Mitigation programs;


WHEREAS, the proposals received by the due date have been reviewed to determine the most qualified and responsive providers for each professional service and scored accordingly;

- Section 1. That Langford be awarded a contract(s) to provide CDBG-MIT program application(s) and project-related **administration services**.
- Section 2. That any and all contracts or commitments made with the above-named services providers are dependent on the successful negotiation of a contract with the service provider;
- Section 3. That the City Manager and/or Mayor are authorized to execute a contract(s) with selected provider.

A RESOLUTION OF THE CITY OF NIXON, TEXAS, AUTHORIZING THE SELECTION OF A PROFESSIONAL SERVICES PROVIDER FOR THE GLO CDBG-MIT GRANT PROGRAM AND GIVING THE AUTHORITY TO THE CITY MANAGER AND/OR THE MAYOR TO EXECUTE A CONTRACT POST NEGOTIATIONS WITH PROVIDER.

WHEREAS, the GLO CDBG-MIT contract requires application preparation and implementation by professionals experienced in the Engineering of State or federally funded disaster recovery projects.

WHEREAS, in order to identify qualified and responsive providers for these services a Request for Qualifications (RFQ) process for engineering services has been completed in accordance with GLO CDBG-MIT requirements.


WHEREAS, the Statement of Qualifications Proposals were received by the due date and have been reviewed to determine the most qualified and responsive providers for each professional service giving consideration to ability to perform successfully under the terms and conditions of the proposed procurement, integrity, compliance with public policy, record of past performance, and financial and technical resources;

NOW, THEREFORE, BE IT RESOLVED:

- Section 1. That BEFCO Engineering firm be approved by council and authorize the City Manager and/or Mayor to negotiate contract terms with BEFCO to provide GLO CDBG-MIT application and project-related **engineering services**. If agreeable terms cannot be reach with BEFCO, the City Manager and/or Mayor are approved to cease negotiations and move to the next highest scoring firm and begin negotiations. With agreeable terms met with the selected engineering firm, the City Manager or Mayor are authorized to sign a contract with the firm.
- Section 2. That any and all project-related services contracts or commitments made with the above-named service provider are dependent on the successful negotiation of a contract with the service provider.
